Innovation is often articulated as a panacea for addressing social and economic problems in the modern world. However the models of innovation that are posed in this context both have often drawn from private sector experience in an undifferentiated way that conflates the manufacturing of products with the delivery of services, and have not taken into account the distinctive characteristics of public rather than private services. In recent years this has begun to evolve, with an important body of research and knowledge on public service innovation (PSI) emerging. Previous PUBSIC Conferences have now taken place in Shanghai, Budapest, Lillehammer and Milan over the past four years. The 5th PUBSIC Conference will now take place at the University of Stavanger, Norway in January 2020 – the final dates will be confirmed by June 2019.
